Short discussion on new meters. We have been replacing about 12 meters per year.

Mr. Hoffman will look into training date for the New Mexico Rural Water Training.

Regarding the lower tank allowing BVFD to use: Board is waiting for Mr. Lucero to advise on his conversations with the BVFD. Board is open to a lease or any other options that the BVFD may be interested.

Board has requested that Mr. Lucero talk to the BVFD regrading the flush and pressure check. They will need to give us some potential dates so we can advise the community. Once Mr. Lucero has the dates, he should contact Mr. Hoffman asap.
